INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our vision is to have a world class system of sustainable National Parks reconnecting and inspiring society.

Our mandate is to deliver on our Conservation Mandate by Excelling in the Management of a National Park System

SANParks therefore require aircraft support for wildlife removals to stock other national parks to comply with contractual agreements, to generate income for the Park Development Fund through wildlife sales, and for SANParks' contribution to the Wildlife Economy. In addition, the management of certain species in smaller parks (e.g. carnivores, rhinos and elephants) requires specialized management interventions such as contraception and translocations and increased anti-poaching activities often require aerial support. Finally, regular wildlife surveys are necessary to determine the effects of all of these interventions, as well as to provide robust information for decision-making for subsequent years.

The rise in poaching of rhino in the Kruger NP has limited the availability of the SANParks helicopters for the above-mentioned operations, even within the Kruger NP itself.

An inability to provide such aerial support timeously poses serious risks to SANParks' ability to undertake the required interventions on schedule, with associated implications for the ecological processes and species being managed.

South African National Parks therefore requires the services of a professional service provider with a suitably experienced pilot to supply and operate a Small-turbine engine helicopter (STEH) and a four-seater piston driven engine helicopter (FSPEH) in all of the national parks.

CONTEXT OF THIS PROCUREMENT

The appointment of a panel of service providers for the provision of helicopter services on an ad-hoc basis to South African National Parks.

CONTRACT PERIOD

The contract will be for a period of three (03) years.

SPECIFICATIONS/SCOPE OF WORK

The following scope of work includes the services that will be required from the successful bidder:

Helicopter services:

Helicopter services include the provision of a Small Turbine Engine Helicopter (STEH) (Jet Ranger or Long Ranger or R66) as well as the helicopter services for a Four (4) Seater Piston Driven Engine helicopter (Similar to a R44 Raven II) (FSPEH). - Other than the return trip to base, helicopter ferries which are not related to operational requirements for SANParks purposes, between operations, will not be chargeable under the contract.
- Guarantee availability of a backup helicopter within 24 hours in case of mechanical failure, at no additional cost to SANParks.
- Provide proof of third-party and passenger liability insurance (minimum R50 million per incident), covering darting and hazardous operations.
- The appointment of a successful bidder to the Panel of Helicopter Services be for a fixed period of three (3) years, which shall be subject to performance review by the SANParks as set out in the Service Level Agreement concluded between SANParks and the successful bidder.
- Each successful bidder shall be required to sign a Service Level Agreement prior to providing the Services.
- The successful bidder will be instructed to provide services as and when required. While the SANParks will use reasonable endeavours to achieve a fair allocation of work to the bidders on the Panel of Helicopter Services, the successful bidder acknowledges that their appointment to the Panel does not guarantee allocation of work.
- SANParks will as and when it requires the Services, in its sole discretion, issue an instruction letter to any bidder on the Panel of Helicopter services.
- A bidder assigned any work may not cede, assign or sub-contract any part thereof to any third party unless with the prior written consent of SANParks.
- SANParks shall be entitled in its sole discretion, to remove a successful bidder from the Panel of Helicopter services before the expiry of the three (3) year's period by written notice for non-compliance with any obligation contained in this

RFP, applicable laws and/or breach of the Service Level Agreement and recall all the files in the bidder's possession.

- Notwithstanding the establishment of a Panel of Helicopter service providers, the SANPARKS reserves the right to procure the provision of legal services from any bidder outside the Panel in accordance with applicable laws

ESTABLISHMENT OF A PANEL

SANParks recommends the bidder who has meet all the mandatory evaluation requirements and technical requirement to form part of the panel.

ISSUING OF WORK / PURCHASE ORDERS TO RENDER A SERVICES WITHIN A PANEL

The panel of service providers will be requested to submit a quotation for the provision of helicopter services on an ad-hoc basis to South African National Parks. **It must be noted that the bidder appointed onto the panel does not automatically mean that you are appointed for a specific service, bidders will still compete on requirements / specifications, lowest price and specific goals, should the highest scoring bidder not be available to deliver on specified timeframes or period or machine, the second highest bidder will be considered for award. Award will be made on the highest scoring points.**

GENERAL CONDITIONS OF CONTRACT

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

GCC1

1. Definitions - The following terms shall be interpreted as indicated:

- 1.1. **“Closing time”** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2. **“Contract”** means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3. **“Contract price”** means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4. **“Corrupt practice”** means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5. **“Countervailing duties”** imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6. **“Country of origin”** means the place where the goods were mined, grown, or produced, or from which the services are supplied. Goods produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7. **“Day”** means calendar day.
- 1.8. **“Delivery”** means delivery in compliance of the conditions of the contract or order.
- 1.9. **“Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10. **“Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies

	are so delivered and a valid receipt is obtained.
1.11.	" Dumping " occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
1.12.	" Force majeure " means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars, or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
1.13.	" Fraudulent practice " means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
1.14.	" GCC " mean the General Conditions of Contract.
1.15.	" Goods " means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
1.16.	" Imported content " means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
1.17.	" Local content " means that portion of the bidding price, which is not included in the imported content if local manufacture does take place.
1.18.	" Manufacture " means the production of products in a factory using labour, materials, components, and machinery and includes other related value-adding activities.
1.19.	" Order " means an official written order issued for the supply of goods or works or the rendering of a service.
1.20.	" Project site ", where applicable, means the place indicated in bidding documents.
1.21.	" Purchaser " means the organization purchasing the goods.

1.23.	" SCC " means the Special Conditions of Contract.
