## 1. PURPOSE

The purpose of this request is to appoint a service provider for furniture removal service for 2 staff members within the Kgalagadi Transfrontier Park. The relocation will involve the transportation of the household furniture to destinations.

- Employee 1 will be from Nossob to 25 President Styn Stree, Die Rand, Upington, 8801
- Employee 2 will be from Mata Mata to Goldengate Highlands Park, Eastern Free State Clarens ,9707

Service providers are requested to submit quotations for the full removal service, including loading, transportation, and offloading of furniture at the respective destinations. Kindly include all associated costs, availability, and any relevant terms and conditions in your quotation.

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

## 3. SCOPE OF WORK

**Kgalagadi Transfrontier Park (RSA)** requires furniture removal services for 2 employees within Kgalagadi Transfrontier Park (Nossob and Mata Mata). The Service provider is required to pack, load, Transport and offload household furniture as follows

### **Furniture removal 1 (Retirement Relocation):**

Collection point: Nossob Rest Camp, Kgalagadi Transfrontier Park

Delivery address: 25 President Steyn Street, Die Rand, Upington, 8801

### **Furniture removal 2 (Transfer Relocation):**

Collection point: Mata Mata Rest Camp, Kgalagadi Transfrontier Park

Delivery address: Golden Gate Highlands National Park, Eastern Free State, Clarens, 9707

### **Additional Requirements:**

- The quotation must include all costs related to packing, loading, transportation, and offloading.
- Service providers must ensure that appropriate vehicles are used for gravel and sandy road conditions.
- Kindly include insurance cover for goods in transit.
- Please indicate availability and estimated timelines for completion of the relocation.
- Ensure provision for VAT (including any applicable increases) for invoicing purposes.

The furniture must be relocated to the respective destinations as outlined above. Kindly note that the removal services should be executed as a combined move, utilising a single transportation arrangement, and not separate transport for each relocation.

***Services are required urgently and within 14 days after Purchase order has been awarded to successful bidder.***
