1. PURPOSE

The purpose of this appointment is to engage a facilitator with proven expertise in strategic planning and facilitation within the conservation and environmental sector, and demonstrable experience working with conservation agencies, protected area authorities, or biodiversity organisations. The facilitator will guide and facilitate a structured strategic review and consultation process involving Outcome Contributors, the Executive Committee (EXCO), and the Board through three dedicated strategic planning sessions. The process will inform the review of the 2025–2030 Strategic Plan, the review of the 2026/27 Annual Performance Plan (APP), and the development of the 2027/28 APP, while ensuring alignment with government planning requirements, national priorities, and SANParks' conservation mandate and long-term strategic objectives.

2. BACKGROUND

South African National Parks (SANParks) is a Schedule 3A public entity under the Department of Forestry, Fisheries and the Environment (DFFE), mandated in terms of the National Environmental Management: Protected Areas Act, 57 of 2003, to conserve, protect, control and manage South Africa's national parks and their biodiversity. SANParks manages 21 national parks across seven provinces, covering more than 4 million hectares and representing approximately 67% of the protected areas under state management.

In accordance with the Public Finance Management Act (PFMA) and the Department of Planning, Monitoring and Evaluation (DPME) Revised Framework for Strategic Plans and Annual Performance Plans, SANParks is required to maintain a five-year Strategic Plan and annual performance planning processes aligned with government priorities and national development outcomes.

SANParks seeks to review its 2025–2030 Strategic Plan, particularly those Key Results Areas and indicators for which baselines were established during the 2025/26 financial year, and which inform the achievement of the 2030 targets. The review will be undertaken in accordance with the DPME Revised Framework for Strategic Plans and Annual Performance Plans and the government's integrated planning framework.

The review must also consider the priorities of the Seventh Administration as articulated in the 2024–2029 Medium-Term Development Plan, as well as relevant planning reforms, including the Policy Framework for Integrated Planning (2022), the National Spatial Development Framework (2022), the District Development Model and related One Plans, and cross-cutting priorities relating to women, youth, persons with disabilities, and the Science, Technology and Innovation (STI) Decadal Plan (2022–2032).

To support this process, SANParks seeks to appoint a suitably qualified facilitator with demonstrated experience in working with conservation agencies, protected area authorities, or biodiversity organisations to facilitate three strategic consultation sessions with Outcome Contributors, EXCO, and the Board, and to support the review of the 2025–2030 Strategic Plan, the review of the 2026/27 APP, and the development of the 2027/28 APP.

3. SCOPE OF WORK

The Service Provider will be required to, amongst others:

- Conduct inception and preparatory meetings with the Chief Executive Officer (CEO), Strategy and Business Performance Team, strategy writer, and project team to confirm the approach, methodology, deliverables, timelines, and stakeholder engagement process.
- Undertake a desktop review of SANParks' current Strategic Plan, Annual Performance Plans (APPs), Annual Reports, Vision 2040, and other relevant conservation and strategic planning documents.
- Review SANParks' organisational and conservation context, including environmental scanning and assessments such as PESTEL and SWOT analysis, with specific consideration of the national and global conservation landscape.
- Analyse and synthesise key findings from strategic and conservation-related documents and consolidate these into discussion papers to inform the strategic review and consultation process.

- Facilitate three strategic consultation sessions, namely:
 - A one-and-half-day strategic review session with Outcome Contributors.
 - A one-and-half-day strategic review session with the Executive Committee (EXCO); and
 - A one-and-half-day strategic planning session with the SANParks Board.

- Facilitate discussions during the three sessions to review and refine the relevant sections of the 2025–2030 Strategic Plan especially where baselines were only determined during the 2025/26 financial year to inform the 2030 targets, the review of the 2026/27 APP where necessary, and the development of the 2027/28 APP.
- Facilitate the application of the Theory of Change methodology to define and refine SANParks’ desired conservation and organisational outcomes and ensure alignment with its legislative mandate, strategic direction, and long-term conservation objectives.
- Prepare and submit comprehensive reports on the outcomes, decisions, and recommendations arising from the engagements with Outcome Contributors, EXCO, and the Board.
- In collaboration with the Strategy and Business Performance Team, support the review of the 2026/27 APP and the development of the 2027/28 APP, including revisions to relevant sections of the 2025–2030 Strategic Plan to be annexed to the APP.
- Provide technical advice on the formulation and refinement of strategic objectives, performance indicators, baselines, and targets to ensure compliance with the SMART principles and government planning requirements.
