1. PURPOSE

The purpose of this request is to appoint a service provider for furniture removal service from Kgalagadi Transfrontier Park. The relocation will involve the transportation of the household furniture to destinations.

- This will be from Nossob rest camp to 25 President Styn Stree, Die Rand, Upington, 8801

Service providers are requested to submit quotations for the full removal service, including loading, transportation, and offloading of furniture at the respective destinations. Kindly include all associated costs, availability, and any relevant terms and conditions in your quotation.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

Kgalagadi Transfrontier Park (RSA) requires furniture removal services from Kgalagadi Transfrontier Park Nossob Rest camp to Upington. The Service provider is required to wrap, pack in boxes, load, Transport and offload household furniture as follows.

Kgalagadi Transfrontier Park is 260km outside of Upington, Tar Road. The first entrance rest camp is Twee Rivieren which is 169km to Nossob Rest camp. Note this is gravel road with Sandy Patches.

See list attached but not limited to extra packing is required for kitchen items such as , Cutlery and Corckery, Cupboards spices ext.

Furniture removal (Retirement Relocation):

Collection point: Nossob Rest Camp, Kgalagadi Transfrontier Park

Delivery address: 25 President Steyn Street, Die Rand, Upington, 8801

Additional Requirements:

- The quotation must include all costs related to packing, wrapping, loading, transportation, and offloading.
- Wrapping and packing breakable item, like crockery
- Service providers must ensure that appropriate vehicles are used for gravel and sandy road conditions.
- This furniture removal truck vehicle should be a closed body, for protecting furniture against weather and securing loads during transit.
- The truck vehicle specifications(specs below)
- Load capacity: 4-5 tonnes
- Cubic volume: 36 and 49 cubic meters
- Box dimensions: Measures 6 to 7 meters in length, 2.2 to 2.4 meters in width, and 2.2 to 2.3 meters in height
- No trailers (open or close)
- No Link trucks due to the roads and terrain.
- Kindly include insurance cover for goods in transit.
- Please indicate availability and estimated timelines for completion of the relocation.
- Ensure provision for VAT (including any applicable increases) for invoicing purposes.
- Please supply proof of ownership and photo of vehicle to be used for the planned removal. (Proof should be a registration document in business name or owner name. picture of vehicle and licence document taken on the day the RFQ is presented)

The furniture must be relocated to the respective destinations as outlined above.

Services are required urgently and within 14 days after Purchase order has been awarded to successful bidder.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
