1. PURPOSE

The purpose of the exercise is to appoint a reputable service provider to remove wooden frames and to supply and install six (6) charcoal aluminium doors and three (3) charcoal aluminium windows at the Regional Office of the Garden Route National Park as per scope below

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. MANDATORY REQUIREMENTS

Installer must have a valid South African Glass and Glazing Association (SAGGA) certificate to issue Glazing Certificates for compliance with the National Building Regulations (SANS10400) – (Certificate to be submitted with RFQ submission)

4. SCOPE OF WORK

- The Office building consists of a ground floor and a top floor.
- Six (6) doors (various sizes) and three (3) windows to be removed and installed, plastered.
- Standard good quality handles, locks, hardware and ironmongery to be used

- **Two (2) of the doors are Emergency Doors with special door closers**
- Glass certificates must be issued after completion of installation
- Installer must adhere to safety, health, environment, risk and quality (SHERQ) procedures
- Safety files must be available before the work starts. A safety representative must always be on site.
- The successful bidder will be required to provide a schedule/timeline for the days of installation to ensure that each door and window is removed separately and installed by the close of business on the same day
