1. PURPOSE

The purpose of this request is to appoint a service provider for supply, installation and maintenance of gas water heaters, maintenance of existing gas stoves and geysers with related equipment at the Wilderness section of the Garden Route National Park for a period of three years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. TERMS OF REFERENCE

1. Contractor Requirements and Qualifications

- **Personnel:** Only qualified artisans (Registered Gas Practitioners) may oversee or perform installation and maintenance.

2. Installation Specifications

- **Certificate of Compliance (CoC):** The contractor must issue a legally valid Certificate of Compliance (CoC) upon completion of any installation, modification, or change of ownership, verifying compliance with SANS standards.
- **Material Standards:** All materials, including pipes, valves, and fittings, must be SABS-approved and appropriate for the specific gas type.
- **Site Management:** Strict adherence to safety regulations regarding ventilation, cylinder placement (e.g., proper housing, distance from electrics), and distance from fixed ignition sources.
- **Pressure Testing:** All installations must undergo mandatory leak detection and pressure testing before commissioning.

3. Maintenance and Service Specifications

- **Preventative Maintenance:** A clear schedule (e.g., annual inspections) for servicing, including cleaning, inspection of valves, and pressure checks.
- **Emergency Response:** A guaranteed 5-hour response time for emergency call-out to minimize risks.
- **Replacement Parts:** All replaced components must meet original manufacturer specifications.
- **Reporting:** A detailed report must be issued after each inspection, highlighting the work done, findings, and any further recommendations.

4. Safety and Regulatory Compliance

- **Legal Compliance:** Adherence to the **Occupational Health and Safety Act (Act 85 of 1993)** and its pressure equipment regulations.
- **Ventilation Check:** Specific focus on ensuring adequate airflow to prevent carbon monoxide buildup, as per manufacturer requirements.

5. Documentation and Handover

- **Data Pack:** A complete data pack with test certificates, material certifications, and a final COC must be handed over.
- **Site Records:** The contractor must maintain a detailed log of all maintenance activities, repairs, and gas usage data, available for inspection.
- **Photographic Evidence:** Documentation (photos) of the installation "before, during, and after" should be submitted with claims.

6. Contract Structure and Performance

- **Warranty:** A 12-month guarantee on all new installations and repairs is standard.

4. MANDATORY REQUIREMENTS

Bidders who fail to meet the mandatory requirements below will be disqualified and will not be evaluated further.

- Bidder must have an active CIDB grading of **2ME or higher**
- Bidder must **fully complete** the compulsory enterprise questionnaire at the end of this document
- Bidder must be registered with the **SAQCC Gas** (South African Qualification and Certification Committee) as a gas installer/ gas practitioner. **Proof of active registration** for the specific type of gas work (LPG, Natural Gas, etc.) must be attached to the bid.

3 POINTS AWARDED FOR SPECIFIC GOALS

3.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
