TERMS OF REFERENCE – APPOINTMENT OF A SERVICE PROVIDER FOR CONSTRUCTION OF TWO PREFAB HOUSES AT MAPUNGUBWE NATIONAL PARK.

The scope of work involves the appointment of building contractor for building two prefab houses required at Mapungubwe National Park. The construction work should be in accordance with relevant SANS standards.
