1. PURPOSE

The purpose of this RFQ is to invite accredited training providers submit price quotation for conducting an accredited Small Vessel Gtr9m: Day Skipper Category C in Cape Town to be attended by 20 participants based in July 2026 (exact date to be confirmed)

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs to appoint accredited training providers to t submit price quotation for conducting an accredited Small Vessel Gtr9m: Day Skipper Category C in Cape Town to be attended by 20 participants in July 2026 (exact date to be confirmed)

Below specifications:

The appointed training provider will be responsible for the following:

I. Training delivery

- Conduct the full Small Vessel (GTR < 9m): Day Skipper Category C training in accordance with SAMSA requirements and standards.

II. Training logistics

- Provide a suitable training venue for the duration of the theoretical component.
- Provide daily catering (lunch and refreshments) for all participants during the training period.

III. Sea time training

- Facilitate and provide a minimum of 25 hours of practical sea time training per participant.
- Arrange and cover the cost of vessel hire for the sea time training.
- Provide catering (lunch and refreshments) during sea time training sessions.

IV. Certification and Compliance

- Facilitate the full application process for the Category C Skipper certification with the South African Maritime Safety Authority (SAMSA), including all associated application fees.
- Cover the cost of the Category C examiner fees.

V. Radio Certification (SRC)

- Facilitate and ensure that all 20 participants obtain the Short Range Certificate (SRC).
- Include all associated SRC training, examination, and application fees.

VI. Medical requirements

- Facilitate SAMSA-approved medical examinations for all 20 participants, including all associated costs.

VII. Additional mandatory training

- Facilitate and provide Medical First Aid training, including Elementary First Aid (MFA), for all participants, ensuring certification upon completion.

VIII. The training provider must supply each participant with necessary learning materials

IX. Facilitate formative and summative assessments in line with accreditation requirements.

X. Ensure all Portfolios of Evidence (PoEs) and all necessary documents are completed and assessed, if necessary

XI. Issue a Certificate of Attendance to all participants.

XII. Provide Statements of Results to all participants who are deemed competent after final moderation and verification.

XIII. Ensure all participants sign the daily attendance register.

XIV. Submit a detail report to the client at the end of the training.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,
- then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below.

(Note to organs of state: Where either the 90/10 or 80/20 preference point system is applicable, corresponding points must also be indicated as such.)
