1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to appoint a suitably qualified and licensed service provider to submit quotations for the supply and delivery of a single once-off bulk delivery of 20,000 litres of Jet A1 fuel to South African National Parks (SANParks).

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

Supply and a single once-off bulk delivery of 20,000 litres of Jet A1 fuel. The service provider is responsible for offloading the fuel directly into the designated storage tank using a suitable fuel tanker. The product and delivery process must meet all national safety and fuel quality standards.

3.1. **Delivery Point:** Air Services, Skukuza Airport

3.2. **Delivery Hours:** 08:00 to 15:00

Note: SANParks uses the following hose to decant fuel into the bulk tank. The tanker truck must be equipped accordingly:

- Aviation Spec Hose – TW75E, wire reinforced, 7 m long
- VC75/3" BSP Male Span-Lock × 2
- ISO45 Hose Unit – 3" BSP
- A valid Certificate of Analysis/Release Certificate must be presented upon delivery to verify fuel quality."

NB: Kindly note that conservation fees will be applicable upon entry into the park.

4. MANDATORY REQUIREMENTS

All mandatory documentation must be submitted by the bidder together with the bid document at the closing date and time of the RFQ. Failure to comply with Mandatory Requirements will lead to the bidder being disqualified and not considered for further evaluation.

- The service provider must hold a valid petroleum license issued by the Department of Mineral Resources and Energy (DMRE) to sell Jet Fuel, classified as a prescribed petroleum product under the Petroleum Products Act, 1977, and associated regulations. A copy of the valid petroleum license must be submitted with the bid documents by the closing date and time. Non-submission or invalid license will result in disqualification of the bid.

5.1. General Principle

- Bidders are required to provide a **firm, all-inclusive price** for the supply and delivery of 20,000L of Jet A1 fuel. The price must include all transport, specialized decanting equipment, and conservation fees. No price escalations will be considered after the closing date of the RFQ.
- Bidders are required to submit a written quotation on the company letterhead.
- The bidder's pricing shall remain firm for a period of **thirty (30)** days from the day following the closing date of this RFQ
- All quoted prices must be inclusive of Value Added Tax (VAT) and account for any price fluctuations, including exchange rate variations. Prices must be quoted in South African Rand (ZAR).
- SANParks reserves the right to engage in negotiations with the recommended bidder prior to the conclusion of the appointment process.

6. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply which requirements as stipulated below:

8. CENTRAL SUPPLIER DATABASE INFORMATION

9. EVALUATION CRITERIA

- 80/20 preference point system will be applicable as the acquisition of goods and services is estimated to be less than the Rand value of R50 million.

Upon appointment the recommended service provider is expected to confirm that they will provide the service on the stipulated dates upon receiving a Purchase Order, failure to adhere to the above, SANParks reserve the right to cancel the issued Purchase Order.

Payment will be made in accordance to the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

13. FINAL AWARD

SANParks recommends the bidder who has quoted on all the items as required in terms of the RFQ for the contract award subject to the bidder having supplied the relevant administrative documentation and complied in all aspects with the terms and conditions as requirements of the RFQ.

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1 POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

Table 1: Specific goals for the tender and points claimed are indicated per the table below.
