1. PURPOSE

The purpose of this RFQ is to invite a supplier for Alarm Monitoring and Armed Response Security Services at Cape Research Centre premises for the period of 18 months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

3. SCOPE OF WORK

SANParks needs the service provider Security Services for the Sales Wild card TMNP

- Quarterly maintenance checks of security equipment established/fitted on site, alarm keypad, office eye sensors, alarm channel receiver, radio antennae and magnetic door sensors.
- Emergency repair services/call out for alarm keypads, radio antennae, office eye sensors, magnetic door sensors, alarm remotes, electrical alarm wiring and alarm 50 channel receiver.
- Bidder response time to alarm should be quick and not be prolonged
- Bidder should notify the end user should alarm go off during weekends
- Panic Buttons linked to alarm system and response services.
- Equipment upgrades/ installation in year 1 applicable once off

No Cash on Delivery (COD) on any services to be rendered including Callouts

- **Period of Contract**

The contract shall be for 36 Months starting from appointment (monitoring, armed response, maintenance, and emergency call out repairs). It is required that the service provider familiarize himself with the details of the site to be serviced to quote accordingly

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
