1. PURPOSE

The purpose of these Terms of Reference is to invite suitably qualified and experienced creative content production partners to submit quotations for a multi-phase brand storytelling, content creation, and production programme across selected South African National Parks. The appointed service provider will serve as an end-to-end creative partner — responsible for ideation, campaign strategy, production, talent management, post-production, and digital distribution across three regions: the Northern Region, Cape Region, and Garden Route Region.

The content produced will serve SANParks' digital marketing, social media, website, and communications needs, and will support increased visitor awareness, bookings, public engagement, inclusive tourism marketing, and conservation awareness across the featured parks and surrounding communities

2. BACKGROUND

South African National Parks manages a network of 21 national parks spanning diverse landscapes, ecosystems, and visitor experiences. While flagship parks such as Kruger National Park enjoy strong digital presence and rich content libraries, many of SANParks' parks remain underrepresented in digital marketing assets relative to their visitor offering.

This content production programme targets three regions, encompassing parks that offer exceptional — and often underexplored — natural, cultural, and recreational experiences:

Northern Region — Golden Gate Highlands National Park

Situated in the northeastern Free State near the Lesotho border, Golden Gate Highlands National Park is renowned for its dramatic golden sandstone and clarens formations, rolling highland meadows, diverse birdlife including the endangered Bearded Vulture, rich rock art heritage, and the recently launched Golden Gate Highlands Dinosaur Museum.

Cape Region — Cape Point, Agulhas, and West Coast National Parks

This region encompasses three distinct but complementary parks along South Africa's southwestern coastline. Cape Point, situated within the Table Mountain National Park, offers dramatic cliff scenery, fynbos biodiversity, and iconic lighthouse heritage. Agulhas National Park marks the southernmost tip of Africa, where the Indian and Atlantic Oceans meet. West Coast National Park is celebrated for its lagoon ecosystem, spring wildflower displays, and rich birdlife.

Garden Route Region — Tsitsikamma, Knysna, and Wilderness National Parks

Tsitsikamma National Park offers dramatic coastline, ancient forests, and adventure activities including the world-famous Storms River suspension bridge. Knysna National Park encompasses the ecologically significant Knysna Lagoon and indigenous forest. Wilderness National Park is a UNESCO-recognised biosphere reserve of lakes, rivers, wetlands, and forested hills.

Each region offers a distinct visual and experiential identity, including the small businesses and community offerings that surround these parks. The appointed service provider must be capable of capturing that identity authentically and compellingly across all content formats.

3. SCOPE OF WORK

The appointed service provider will function as a creative content partner, responsible for the full content lifecycle — from campaign ideation and strategy through to production, post-production, and digital distribution — across three regions and seven national parks. All production activities must be conducted in accordance with SANParks' park access, safety, and environmental protocols. The scope is structured across three phases:

Phase 1 — Northern Region (July 2026)

- Park: Golden Gate Highlands National Park
- Shoot duration: 3 days

Phase 2 — Cape Region (August 2026)

- Parks: Cape Point, Agulhas, and West Coast National Parks
- Shoot duration: 7 days

Phase 3 — Garden Route Region (September 2026)

- Parks: Tsitsikamma, Knysna, and Wilderness National Parks
- Shoot duration: 7 days

The following scope applies to each phase:

A. Narrative Framework & Creative Direction

All content produced under this contract must be guided by the following narrative framework, which the service provider must interpret and apply during the ideation phase and carry through to all production and post-production deliverables.

Narrative Pillars

- Heritage & Conservation: Position each park as a guardian of biodiversity, geological heritage, and cultural legacy.
- Adventure & Discovery: Capture the thrill of exploration, wildlife encounters, and once-in-a-lifetime visitor experiences.
- Community & Culture: Elevate local voices, traditions, SMME offerings, and authentic community encounters.
- Wellness: Showcase eco-friendly stays, natural retreats, and curated park experiences.

Emotional Story Pillars

- Arrival & Anticipation: The emotional build-up before entering a destination.

- Immersion & Experience: The sensory richness of wildlife, landscapes, and activities.
- Reflection & Sharing: Encouraging visitors to retell their stories online and offline.
- Legacy & Impact: Linking tourism to conservation, community upliftment, and future generations.

All creative concepts, shot lists, scripts, and copy must be developed in alignment with these pillars and submitted for SANParks approval before production commences.

B. IDEATION & CREATIVE STRATEGY

Prior to pre-production planning for each phase, the service provider must develop and submit a comprehensive creative strategy for SANParks approval.

This must include:

- Campaign concept per region, including overarching theme, narrative arc, and content angles aligned to the Narrative Framework above.
- Platform-specific content ideas for Instagram Reels, TikTok, YouTube Shorts, Facebook, LinkedIn, and owned SANParks channels.
- Proposed storytelling formats per deliverable, including short-form video, photo narratives, micro-stories, and experiential diaries.
- Proposed talent and voice approach per phase, identifying the types of local ambassadors, guides, artisans, and community members to be featured.
- Storyboards or treatment documents for the Hero Brand Film per phase.

No production activity may commence until the creative strategy for that phase has been reviewed and approved in writing by SANParks.

C. Pre-Production Planning

- Develop a detailed production plan per phase, informed by the approved creative strategy, including shot lists, scene descriptions, call sheets, and scheduling for all photography and videography sessions.
- Conduct a location recce (in person or virtual) in consultation with the relevant park management to identify optimal locations, times of day, and conditions for each content category, including identification of local SMMEs and community ambassadors to be featured.
- Prepare a creative brief for approval by SANParks prior to each shoot, confirming visual direction, brand alignment, and content priorities per park.
- Coordinate equipment logistics in consultation with the relevant park management. Note: travel and accommodation for the production team will be arranged and covered by SANParks via its appointed travel agent; the service provider is not required to cost for travel, accommodation, or subsistence in this RFQ.

- Obtain all necessary permissions, clearances, and drone authorisations (CAA-compliant) prior to each shoot.
- Source and brief all talent, local ambassadors, guides, artisans, and community participants confirmed for each phase.

D. Still Photography

The service provider must deliver a minimum of 150 final edited, high-resolution images per phase, covering the following categories:

- Landscape & Scenery: Iconic natural formations, vegetation, coastal scenery, sunrise and sunset, and aerial perspectives where applicable.
- Wildlife: Species relevant to each park and region, captured in natural settings.
- Activities & Visitor Experience: Guests participating in activities, using trails, visiting attractions, and enjoying accommodation — reflecting diversity of visitors.
- Accommodation: High-quality imagery of all key accommodation types within each park, including chalets, campsites, rest camps, and lodges.
- Cultural & Heritage: Rock art, heritage sites, geological features, and interpretive assets where applicable.
- Local SMME & Community Products: Photography of small, medium, and micro enterprise (SMME) products, crafts, and offerings available in and around each park, supporting inclusive tourism marketing.
- Photo Narratives: Visual essays combining photography and short captions that link landscapes, wildlife, and people to human stories, suitable for use across SANParks digital platforms and publications.
- Aerial Photography (Drone): Wide-angle aerial perspectives of park landscapes, formations, coastlines, and accommodation precincts (CAA-compliant).

All images must be delivered in RAW and high-resolution JPEG/TIFF formats, fully edited and colour-graded. A selection must also be provided in web-optimised formats.

E. Videography

The service provider must deliver the following video assets per phase, fully edited with colour grading, music licensing, and subtitling where applicable:

- Hero Brand Film (2–3 minutes): A cinematic flagship film per region capturing the landscape, wildlife, activities, and visitor experience of the featured parks, for use across digital platforms and presentations.
- Short-Form Social Media Clips (30–60 seconds each, minimum 6 clips per phase): Vertical and landscape format clips optimised for Instagram Reels, TikTok, YouTube Shorts, and Facebook — covering wildlife, landscape, activities, and accommodation.
- Accommodation & Experience Clips (60–90 seconds each, minimum 3 clips per phase): Short showcase videos for key accommodation types and park activities.

- SMME Showcase Clips (30–45 seconds each, minimum 2 clips per phase): Short clips featuring local SMME products and offerings in and around each park.
- Micro-Stories (15–30 seconds each, minimum 3 per phase): Episodic short-form content designed to build anticipation and engagement across Instagram, TikTok, and YouTube Shorts.
- Experiential Diaries (60–90 seconds each, minimum 2 per phase): Ranger logs, traveler journals, or artisan spotlights told in first-person narrative format, optimised for social platforms.
- Drone Aerial Video (1–2 minutes per phase): Cinematic aerial footage of landmark landscapes, coastlines, and accommodation precincts.
- B-Roll Footage Package: Minimum 30 minutes of unedited, high-quality B-roll footage per phase, across all categories, for use by the SANParks internal team in future productions.

All video deliverables must be provided in 4K resolution where applicable, with separate audio tracks.

At the time of the shoot, the drone operator will need to have a valid CAA (Civil Aviation Authority) drone license.

F. Copywriting

The service provider must deliver the following written content per phase:

- Park Descriptions: Engaging, brand-aligned descriptive copy for each park featured in the phase, suitable for use on the SANParks website and in travel trade materials (minimum 300 words per park).
- Activity & Experience Descriptions: Short descriptive copy for key visitor activities and experiences at each park (minimum 100 words per activity, minimum 3 activities per park).
- Accommodation Descriptions: Descriptive copy for each key accommodation type at each park (minimum 150 words per accommodation type).
- SMME Descriptions: Short descriptive copy for featured local SMME products and offerings (minimum 100 words per feature, minimum 2 features per phase).
- Experiential Diary Scripts & Copy: Written scripts and copy for ranger logs, traveler journals, and artisan spotlights, aligned to the video deliverables above (minimum 2 per phase).
- Social Media Captions: A set of platform-ready captions per phase for Facebook, Instagram, X (Twitter), and LinkedIn, aligned to the visual content produced.

All copy must be submitted in editable format and must be approved by SANParks before being considered final.

G. TALENT & VOICE

The service provider is responsible for sourcing, briefing, and managing all talent and on-camera voices required for content production across each phase. This includes:

- Local Ambassadors: Park guides, rangers, conservationists, artisans, and SMME operators serving as authentic on-camera narrators and storytellers.
- Influencers & Content Creators: Recruitment, briefing, and performance tracking of relevant influencers and digital content creators aligned to SANParks' brand values and target audiences, including adventure travelers, eco-bloggers, and wellness advocates.
- Visitor Voices & User-Generated Content: Facilitation of visitor participation and user-generated content that amplifies authenticity across platforms.

All talent must be briefed against the approved creative strategy and Narrative Framework. Talent agreements, usage rights, and any associated costs are the responsibility of the service provider and must be factored into the bid price.

H. Post-Production & Asset Delivery

- All content must be professionally edited, colour-graded, and quality-checked before delivery.
- Provide professional voice-over narration for the Hero Brand Film per phase, in a tone and language aligned with SANParks' brand guidelines. Voice-over scripts must be submitted for SANParks approval prior to recording.
- Optimise all video deliverables for platform-specific formats and specifications, including vertical format for TikTok and Instagram Reels, landscape format for YouTube, and square format for Facebook where applicable.
- Apply subtitling to all video deliverables.
- Deliver a fully organised and labelled digital asset library via a secure shared platform (Google Drive, Dropbox, or equivalent), categorised by park, content type, and format.
- Provide metadata tagging on all photography files (location, subject, date, keywords).
- All final assets per phase must be delivered within four (4) weeks of the completion of each production shoot.
- Raw and unedited footage and files must be included in the final delivery for each phase.

I. DISTRIBUTION & AMPLIFICATION

The service provider is responsible for the scheduling, placement, and amplification of content across the following channels:

- Owned Media: SANParks website, newsletters, and blogs — in coordination with the SANParks communications team.

- Social Platforms: Instagram, TikTok, YouTube Shorts, Facebook, and LinkedIn.
- Paid Amplification: Targeted paid media campaigns directed at adventure seekers, families, and eco-luxury travelers, using the content produced under this contract.
- Partnership Channels: Coordination with airlines, resorts, travel brands, and other relevant partners to extend content reach.

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with which requirements as stipulated below:

The supplier shall not make, without the purchaser's prior written consent, use of any document or information mentioned in GCC clause 5.1 except for purposes of performing the contract. 5.3. The performance security shall be denominated in the currency of the contract, or

	in a freely convertible currency acceptable to the purchaser and shall be in one of the following forms: 7.3.1. bank guarantee or an irrevocable letter of credit issued by a reputable bank located in the purchaser's country or abroad, acceptable to the purchaser, in the form provided in the bidding documents or another form acceptable to the purchaser; or 7.3.2 a cashier's or certified cheque 7.4. The performance security will be discharged by the purchaser and returned to the supplier within thirty (30) days following the date of completion of the supplier's performance obligations under the contract, including any warranty obligations, unless otherwise specified in SCC.

	8.1. All pre-bidding testing will be for the account of the bidder. 8.2. If it is a bid condition that supplies to be produced or services to be rendered should at any stage during production or execution or on completion be subject to inspection, the premises of the bidder or contractor shall be open, at all reasonable hours, for inspection by a representative of the purchaser or an organization acting on behalf of the purchaser. 8.3. If there are no inspection requirements indicated in the bidding documents and contract makes no mention, but during the contract period, it is decided that inspections shall be carried out, the purchaser shall itself make the necessary arrangements, including payment arrangements with the testing authority concerned. 8.4. Any contract supplies may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. GCC10	10. Delivery and Documentation
	10.1. The supplier in accordance with the terms specified in the contract shall make delivery of the goods/services. The SCC specifies the details of shipping and/or other documents furnished by the supplier. 10.2. Documents submitted by the supplier are specified in SCC.
GCC11	11. Insurance
	11.1. The goods supplied under the contract are fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
GCC12	12. Transportation
	12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.
GCC13	13. Incidental services
	13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC: 13.1.1. Performance or supervision of on-site assembly and/or commissioning of the supplied goods; 13.1.2. Furnishing of tools required for assembly and/or maintenance of the supplied goods; 13.1.3. Furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods; 13.1.4. Performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and

	13.1.5. Training of the purchaser's personnel, at the supplier's plant and/or on-site, conducted in assembly, start-up, operation, maintenance, and/or repair of the supplied goods. 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
GCC14	14. Spare parts
	14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: 14.1.1. Such spare parts as the purchaser may elect to purchase from the supplier, provided that this election shall not relieve the supplier of any warranty obligations under the contract; and 14.1.2. 	design and/or material is required by the purchaser's specifications) or from any act or omission of the supplier, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination. 15.2. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty. 15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.
GCC16	16. Payment
	16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC. 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract. 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier. 16.4. Payment will be made in Rand unless otherwise stipulated in SCC

GCC17	17. Prices
	17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
GCC18	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC19	19. Assignment
	19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
GCC20	20. Subcontract
	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
GCC21	21. Delays in supplier's performance
	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the

	goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority. 21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available. 21.5. Except as provided under GCC Clause 25, a delay by the supplier in the performance of its delivery obligations shall render the supplier liable to the imposition of penalties, pursuant to GCC Clause 22, unless an extension of time is agreed upon pursuant to GCC Clause 21.2 without the application of penalties. 21.6. Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the supplier's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the supplier.

If the supplier fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 21.2; 23.1.2. If the Supplier fails to perform any other obligation(s) under the contract; or 23.1.3. If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed. The parties agree that all right, title, and interest in the contract intellectual property rightly invests in SANParks and to give effect to the foregoing: (a) The contracted supplier hereby assigns all rights, titles, and interests in and to the contract intellectual property that it may own to SANParks and SANParks hereby accepts such assignment, and (b) The contracted supplier undertakes to assign in writing to SANParks all contract intellectual property and which may invest in the contracted supplier. The contracted supplier shall keep the contract intellectual property confidential and shall fulfil its confidentiality obligations as set out in this document. The contracted supplier shall assist SANParks in obtaining statutory protection for the contract intellectual property at the expense of SANParks wherever SANParks may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to SANParks, or as SANParks may direct, and to support SANParks, or its nominee, in the prosecution and enforcement thereof in any country in the world. The contracted supplier hereby irrevocably appoints SANParks to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that SANParks, in its absolute discretion, requires in order to give effect to the terms of this clause. The rights and obligations set out in this clause shall service termination of this contract indefinitely.
	Confidentiality The recipient of confidential information shall be careful and diligent as not to cause any unauthorised disclosure or use of the confidential information, in particular, during its involvement with SANParks and after termination of its involvement with SANParks, the recipient shall not: (a) Disclose the confidential information, directly or indirectly, to any person or entity, without SANParks' prior written consent. - (b) Use the confidential information otherwise than as may be strictly necessary for the execution of the contract,

The recipient shall take all such steps as may be reasonably necessary to prevent the confidential information from falling into the hands of any unauthorised third party.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove:

- (a) Was independently developed by the recipient prior to its involvement with SANParks or in the possession of the recipient prior to its involvement with SANParks;
- (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient;
- (c) Was lawfully received by the recipient from a third party acting in good faith having a right of further disclosure and who do not derive the same directly or indirectly from SANParks, or
- (d) Is required by law to be disclosed by the recipient, but only to the extent of such order and the recipient shall inform SANParks of such requirement prior to any disclosure.

The recipient shall within one (1) month of receipt of a written request from SANParks to do so, return to SANParks all material embodiments, whether in documentary or electronic form, of the confidential information including but not limited to:

- (a) All written disclosures received from SANParks;
- (b) All written transcripts of confidential information disclosed verbally by the SANParks; and
- (c) All material embodiments of the contract intellectual property.

The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been made available to the recipient, but for the obligations of confidentiality agreed to herein.

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences or relationships by furnishing of confidential information by either party pursuant to this contract.
