1. PURPOSE

The purpose of this request for quotation (RFQ) is to appoint a qualified, appropriately certified service provider to conduct a total reward audit to give assurance that the total reward resulted in accurate remuneration of SANParks employees.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks makes use of the SAGE300 system to manage its payroll for +- 6000 employees monthly.

3. SCOPE OF WORK

SANParks requires the services of an independent, competent and appropriately certified service provider to conduct a comprehensive payroll business process analysis to assess the efficiency, control environment, compliance, and operational effectiveness of payroll processes, and to design an optimised future-state payroll operating model aligned to SANParks governance and best practice.

The service provider must provide the below services:

1. Process Mapping:

- Conduct detailed end-to-end mapping of current payroll processes, including:
 - Monthly payroll cycle
 - Year-end payroll processes
 - Third-party payments
 - Payroll inputs to final payment execution
- Document process dependencies across departments (HR, Finance, IT, Operations)

- Mapping of payroll Audit and segregation of duties
- Map out the payroll reconciliation and variance reporting to ensure accuracy and transparency in payroll processing.

2. Controls and Compliance Review

- Map and evaluate:
 - Segregation of duties
 - Access controls within Sage300
 - Authorization levels and approval workflows
- Assess alignment to:
 - SARS tax compliance obligations

A maximum of 80 points is allocated for price on the following basis:
