1. PURPOSE

The purpose of this exercise is to appoint a service provider to conduct whistleblowing training for the Board and Executive Management of South African National Parks.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under the National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of the transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

Board members play a critical governance role under the Protected Disclosures Act, Act 26 of 2000, as amended (PDA). While the act primarily protects employees from occupational detriment, directors act as the "employer's" responsible agents and are legally required to establish internal reporting channels, protect whistleblowers, and thoroughly investigate all disclosures.

3. SCOPE OF WORK

Specifications are as follows:

SANParks is seeking to appoint a service provider to conduct whistleblowing training for the Board and Executive Management with regard to the requirements of the Protected Disclosures Act, Act 26 of 2000, as amended.

The training will ensure that members are well informed of their legal duties and are empowered to exercise their role and responsibilities effectively in compliance with the legislation.

The training should cover at least the following areas

- The Protected Disclosures Act no.26 of 2000 (as amended).
- Proposed reforms for the whistleblower protection regime, i.e the draft Protected Disclosures Bill, 2026
- Legal and governance duties of the Board in implementing compliance measures.
- Procedures for handling disclosures
- Protection mechanisms for whistleblowers;
- Best practices for promoting an ethical organisational culture; and
- Practical examples, case studies, or scenario-based learning.

Qualifications and experience of the service provider.

- Proven experience in corporate governance, compliance, ethics training.
- Knowledge of whistleblowing laws and proposed reforms.
- At least 5 or more years' experience in providing training or advisory services in corporate governance, ethics, or compliance.

EVALUATION CRITERIA

There are 3 main stages in the selection process, namely, ensuring that bids comply with administrative Compliance, Functionality Evaluation and Price and preference points

STAGE 1: ADMINISTRATIVE COMPLIANCE REQUIREMENTS

- Registration on National Treasury CSD report
- Comprehensive quotation (prices must be VAT Inclusive)

- Fully Completed and signed Standard Bidding Documents (SBD) forms documents

Bidders must achieve **75% minimum qualifying score** to move to the next phase. Bidders who fail to comply with the set minimum threshold of 75% of the technical requirements will be eliminated. Service Providers must attain a minimum threshold of 70 points or more to be considered for evaluation on the 80/20 Preference Point System.

Failure to attain the set minimum threshold will result in a disqualification.

STAGE 3: EVALUATION 80/20 PREFERENCE POINT SYSTEM

- The price quotations will be evaluated in accordance with the pre-scripts of the Preferential Procurement Policy Framework Act (PPPFA) and its Regulations, in particular Preference Procurement Regulation 2022 which stipulate 80/20 preference point system for acquisition of goods or services with Rand value equal to or below R50 million (inclusive of all applicable tax).
- A maximum of 80 points for price and 20 points for the specific goal specified on the request for quotation may be awarded to a Service Provider.

The 80/20 preference point system will be applicable in this tender. The lowest/highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

3.1. POINTS AWARDED FOR PRICE

4. POINTS AWARDED FOR SPECIFIC GOALS

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (SANParks) cannot amend the National Treasury’s General Conditions of Contract (GCC). SANParks appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

If a court of law convicts a person of an offence as contemplated in sections 12 or

	13 of the Prevention and Combating of Corrupt Activities Act, No. 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. Every written acceptance of a bid shall be posted to the supplier concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice 31.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of

	32.1. A foreign supplier shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country. 32.2. A local supplier shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser. 32.3. No contract shall be concluded with any bidder whose tax matters are not in order.
