## 1. PURPOSE

The purpose of this request is to appoint a service provider for manufacturing and erecting of a modular satellite library in Hornlee, Knysna section of the Garden Route National Park.

## 2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

## 3. SPECIFICATIONS

### 1. General Specifications of Modular Library Unit

- 1.1 The modular library unit shall be designed and manufactured as a complete unit and transported to and sited on the required position on site.
- 1.2 The unit shall be designed to be structurally sound.
- 1.3 The unit shall be designed and built to withstand harsh, outdoor climatic conditions.
- 1.4 The unit shall be assembled in an ISO 9001/2008 accredited factory. ***Proof of accreditation must be provided.***
- 1.5 The unit shall be made of hard-wearing, durable material and good quality finishes and fittings shall be used.
- 1.6 The unit shall be fully insulated, ensuring a high level of comfort.
- 1.7 The unit shall be designed and manufactured to be 100% re-locatable.
- 1.8 The unit shall **NOT** be made of a shipping container.
- 1.9 The unit shall be ready for immediate use once delivered and sited with external services ready for connection.

## **2. Foundation and siting**

- 2.1 The unit shall be supported on adjustable steel leveling jacks and concrete pads to create a stable foundation for the building.
- 2.2 The successful tenderer shall specify their foundation requirements which are to be completed by others.

## **3. Chassis**

- 3.1 The chassis of the unit shall be manufactured from 2.5mm or 3mm steel lipped channel with heavy duty cross members welded together into a rigid ladder frame.
- 3.2 Steel must be washed, treated and painted at the factory to prevent rust.
- 3.3 Adjustable steel jacks must be welded to the chassis to allow the chassis to be leveled on site.

## **4. Floor**

- 4.1 The floor of the unit shall consist of a minimum of 18mm thick CCA treated exterior grade shutter ply board. One coat of bitumen undercoat to be applied to the underside of floorboards as further protection against moisture.
- 4.2 The floor finish shall consist of heavy-duty 2mm industrial vinyl sheeting.
- 4.3 The children's section of the library shall be fitted with a 2500x2700mm carpet on top of the vinyl floor finish as specified on the drawings.

## **5. Walls**

- 5.1 The walls of the unit shall be constructed of sandwich panels with at least 60mm polystyrene, or 40mm polyurethane core with 0,58mm rigidised chromadek on both sides.
- 5.2 The panels shall have double interlocking profiled edges, giving a flush weatherproof joint.
- 5.3 The core shall have the following insulation properties.
  - 60mm thick polystyrene of U-value = 0,60 W/M<sup>2</sup> °C
  - 40mm thick polyurethane of U-value = 0,55 W/M<sup>2</sup> °C
- 5.4 Both types of core material shall be fire retardant.

## **6. Roof and Ceiling.**

- 6.1 The roof and ceiling shall be constructed of combined roof/ceiling interlocking sandwich panels to form a vaulted ceiling.
- 6.2 Roof/ceiling panels shall consist of 0,5mm IBR profile chromadek top skin, 50mm thick water impervious polystyrene core and 0.58mm rigidised chromadek inner skin, which serve as the ceiling.
- 6.3 The roof panel shall have an interlocking profile, which provides a weatherproof joint.
- 6.4 Ceiling height at eaves shall be a minimum height of 2400mm and at the apex a minimum height of 2700mm.
- 6.5 PVC gutters with downpipes shall be fitted to accommodate rainwater.

## **7. Windows**

- 7.1 Windows shall consist of outward opening top hung aluminium windows with 4mm glass panes as specified on the drawing.
- 7.2 Burglar bars shall be fitted to inside of all the windows.
- 7.3 Vertical blinds shall be fitted to all windows.

## **8. Doors**

- 8.1 Doors shall be manufactured from the same materials as the walls.
- 8.2 Exterior door - Chromadek cladding with a polystyrene or polyurethane core and fitted with chromadek weather trims and 3-lever mortice lock.
- 8.3 Interior door - Chromadek cladding with a polystyrene or polyurethane core and fitted with 2-lever mortice lock.

## **9. Security Gates**

- 9.1 A single sliding/folding security gate shall be fitted for the main door.

## **10. Access and Ramp for disabled persons**

- 10.1 A 1.2m wide galvanized steel 3-tier access steps with landing and ramp to make provision for disabled persons shall be fitted as specified on the drawing.
- 10.2 The access and ramp shall be fitted with handrails.
- 10.3 The ramp shall have a low gradient in order to make it easy for a disabled person to negotiate it.
- 10.4 The access and ramp shall be covered by a veranda.

## **11. Veranda**

11.1 A veranda of 1.5m wide x 6m long shall be erected and fitted with a PVC gutter and downpipe.

## **12. Electrical installation**

12.1 Positions of the distribution board, lights and electrical plug points shall be as indicated on electrical layout drawing.

12.2 All electrical fittings shall be surface or flush mounted.

12.3 A "Certification of Electrical Compliance" (COC) shall be issued.

12.3 Distribution board: 220 v with earth leakage.

12.4 Lights fittings:

1200mm double fluorescent lights. (8 No. off).

PL2X9W circular external lights. (2 No. off).

12.5 Plug points:

16A double plug points 300mm above floor level. (7 No. off).

16A double plug point 1300mm above floor level. (3 No. off).

Air conditioner isolator points. (2 No. off).

12.6 Light switches: 3 lever. (1 No. off).

## **13. Air Conditioning**

13.1 Two 18 000 BTU split-unit air conditioning units shall be fitted to the unit at the positions indicated on the drawing.

## **14. Plumbing**

14.1 Sink: 800x460mm Franke Projectline PLN611 or equivalent Inset Kitchen Sink with 38mm PVC waste fittings and plug.

14.2 Sink to be fitted to kitchen countertop.

## 15. Kitchen and work cabinets

- 15.1 Kitchen and work cabinets shall be fitted as specified on the drawing.
- 15.2 Top and bottom cupboards of colour melamine with impact edging.
- 15.3 Kitchen counter shall have 2100x600mm post formed Formica top.
- 15.4 Work counter shall have 2700x600mm post formed Formica top.
- 15.5 Cupboard door handles to be matt chrome Whale handles

## 16. Library Furniture

### 16.1 Bookshelves

- 16.1.1 Bookshelves (A) shall be manufactured from Saligna wood – 915 (W) x 1400 (H) x 300 (D) with 4 shelves.
- 16.1.2 Bookshelves (B) shall be manufactured from Saligna wood – 915 (W) x 2000 (H) x 300 (D) with 6 shelves.
- 16.1.3 Bookshelves (C) shall be manufactured from Saligna wood – 915 (W) x 1400 (H) x 300 (D) with 3 shelves.
- 16.1.4 Bookshelves (D) shall be manufactured from Saligna wood – 915 (W) x 1400 (H) x 300 (D) with flat bottom shelf and 2 slanted top shelves with lips.

**1 GENERAL CONDITIONS**

**1.1** The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

- (c) “**rand value**” means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) “**tender for income-generating contracts**” means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) “**the Act**” means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
