1. PURPOSE

The purpose of this request is to appoint a service provider that will provide Snake identification, basic handling, and snakebite treatment training course for hundred and fifteen (115) employees at Bontebok National Park-Swellendam, Table Mountain National Park-Cape Town and Westcoast National Park-Langebaan in the Cape Region.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

South African National Parks (SANParks) invites Training Providers for the Snake identification, basic handling, and snakebite treatment training course for hundred and fifteen (115) employees at Bontebok National Park-Swellendam, Table Mountain National Park-Cape Town and Westcoast National Park-Langebaan Park in the Cape Region.

Requirements:

- The service provider shall provide 1 (one) x suitably qualified facilitator per park for the duration of the training sessions.
- The service provider shall provide 1 (one) moderator and 1 (one) assessor for the whole programme
- Each facilitator shall be assigned to a specific park and shall be available to conduct the required training independently and concurrently with the facilitators assigned in other parks.
- The requirement for 1 (one) facilitator per park is intended to ensure that the scheduled training activities can be conducted concurrently across all participating parks in the Cape Region, without the need for facilitators to rotate between parks or delay activities at one park to accommodate another.
- The service provider shall therefore ensure sufficient suitably qualified personnel are available to service all parks simultaneously, where the program requires concurrent implementation.

At the end of the training participants must have knowledge and be able to understand:

- **Basic Snake Biology:** Understand snake life, including sensory perceptions, movement, hunting techniques, and reproductive behaviors, to enhance workplace safety.
- **Basic Snake Identification:** Focus on identifying the most dangerous snakes you may encounter, alongside commonly found mildly and non-venomous species.
- **Snake Awareness:** Address common misconceptions and folklore surrounding snakes, highlight the importance of snake conservation, and provide practical measures to minimize snakebite risks in the workplace.
- **Snakebite Treatment:** Learn essential pre-hospital first aid measures, including CPR, rescue breathing, pressure bandages, and tourniquets for neurotoxic bites, with guidance on correct usage to prevent harm.
- **Safe Snake Handling Techniques:** Explore commonly available equipment for snake handling, how to use it safely, and the proper procedures for managing captured snakes. Practical components include snake hooks, tongs, buckets, and tubes, with a strong emphasis on safety and responsibility.
