1. PURPOSE

The purpose of this RFQ is to invite a suitably experienced service provider to provide General Maintenance Services for a period of thirty-six (36) months.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

The South African National Parks require the services of a suitably experienced service provider to provide general maintenance labour for a period of thirty-six (36) months.

The service provider shall provide a team of eight (8) workers, comprising:

4 × Skilled Workers

4 × General Workers

The labour will be utilized for routine and reactive maintenance activities at our facilities, as and when required.

Agulhas National Park (ANP) has a set of infrastructures that require regular maintenance and repair. From time-to-time problems occur that require repair to conform to safety standards and ensure that acceptable levels of services are provided to over 1 million paying visitors. Services could include basic plasterwork, tiling, fencing, paintwork, paving and building work to repair accommodation units, official standby quarters, official residences, visitor centers, plant rooms, fire hydrants and general office areas. The area in question encompasses the following geographic areas.

- Agulhas National Parks main Office
- Agulhas Rest camp in Suiderstrand
- Bosheuwel precinct
- Bergplaas Accommodation
- Renosterkop Accommodation
- Waterford accommodation
- Ratelriver accommodation
- Rietfontein accommodation
- Staff house accommodations at Suiderstrand

- Lighthouse precinct
- Any other facility (under Agulhas National Park) as identified by the Park.

The above lists the general areas where maintenance may be required and is limited to SANParks facilities only.

Services to be rendered

- Provision of basic infrastructure repairs on approval of quote.
- Provide for an hourly rate for repairs during working hours (including transport)
- Provide for an hourly rate for work/ repairs after hours, weekends and public holidays (including transport)
- Ensure same day callout as per the work approval procedures.

Labour-Only Requirement

This is a labour-only requirement.

SANParks will provide the materials required for the maintenance works, while the service provider will be responsible for providing the required labour resources.

The service provider shall ensure that all workers:

- Are suitably experienced for their assigned duties.
- Comply with the Employer's health and safety requirements.
- Report for duty as scheduled.
- Wear appropriate PPE as required.
- Maintain acceptable standards of workmanship and conduct.
- Comply with instructions issued by the authorized representative.

Work Callout procedures: These steps are to be followed without exception

1. Contractor dispatches staff to assess and cost the task at hand.
2. The quotation for materials is to be submitted to the Technical Officer for approval. Time and travel is at a set rate and to be logged and signed off by the Park Manager, Technical Officer or Section Ranger prior to invoicing.

Site inspections:

- A. Evaluate the site and condition and maintenance needs before undertaking work
- B. Do planning before work can be done
- C. Assess the risks involved before performing the work
- D. Assess the scope of the work to ensure public safety throughout the repairs/ maintenance
- E. Establish the work needs and components required to be done before quoting

Site safety

Note: Please note that the Agulhas National Park is a public facility and as such the outmost care needs to be taken to always ensure public safety.

PPE should be worn at all times

Surroundings

- Signage at the place of work
- Access and escape routes
- Environmental considerations
- Work positioning and starting machinery
- equipment and fuel storage
- pre-start checks

Access

Access from Agulhas Main office to be coordinated with the Technical Officer or Section Ranger before entry. Access to the other sites will be opened as per arrangements with operational staff in terms of locked gates, accommodation units, offices etc. Approval from the Park Manager, Technical Officer or Section Ranger is required before after-hours weekends or public holidays will be permitted.

Special Instruction

- Be available to provide a service 365 days a year
- Contractor to be able to respond within two hours.

Period of Contract

The contract shall be for a period 36 months.
