1. PURPOSE

South African National Parks (SANParks) invites suitably qualified service providers to submit quotations for the supply, installation, support, and maintenance of an uncapped Wi-Fi solution at Tankwa Karoo National Park for a period of Thirty-Six (36) months.

BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

2. SCOPE OF WORK

SANParks needs to appoint a company for the Supply, installation, support and maintenance of Uncapped Wi-Fi at Tankwa Karoo National Park for a Period of Three (3) Years.

Please take note that the park does not have any cellular coverage for LTE, and a different medium connectivity will be required.

2.1. Locations

The service provider shall provide connectivity to the following locations:

- **10 x COTTAGES (ELANDSBERG WILDERNESS CAMP)**
- **01 x DE ZYFER COTTAGE**
- **01 x PAULSHOEK COTTAGE**
- **02 x TANQUA GUESTHOUSE**
- **Monthly uncapped 10mbps data for a period of 3 years and support maintenance as and when required.**

2.2. Minimum Technical Requirements:

The successful bidder shall:

- Conduct a site assessment prior to installation.
- Supply and install all required equipment.

- Supply mounting brackets, poles, cabling and accessories.
- Install indoor and outdoor wireless access points where required.
- Configure secure wireless networks.
- Configure network management and monitoring.
- Commission and test the complete solution.
- Provide internet connectivity to all listed sites.
- Provide a minimum bandwidth of 10 Mbps uncapped per site (or higher if proposed).
- Ensure reliable coverage throughout each accommodation unit.
- Supply surge protection and weatherproof equipment where required.
- Ensure compliance with all relevant ICASA regulations where applicable.

The proposed solution shall include all hardware, software, installation, licensing (where applicable), commissioning, monitoring, technical support, and maintenance required for a fully operational service.

2.3. Support and Maintenance

The successful bidder shall provide:

- Remote Technical support as and when required
- On-site technical support when remote resolution is unsuccessful – as and when required
- Preventative maintenance – as and when required
- Software and firmware updates.
- Replacement of faulty equipment

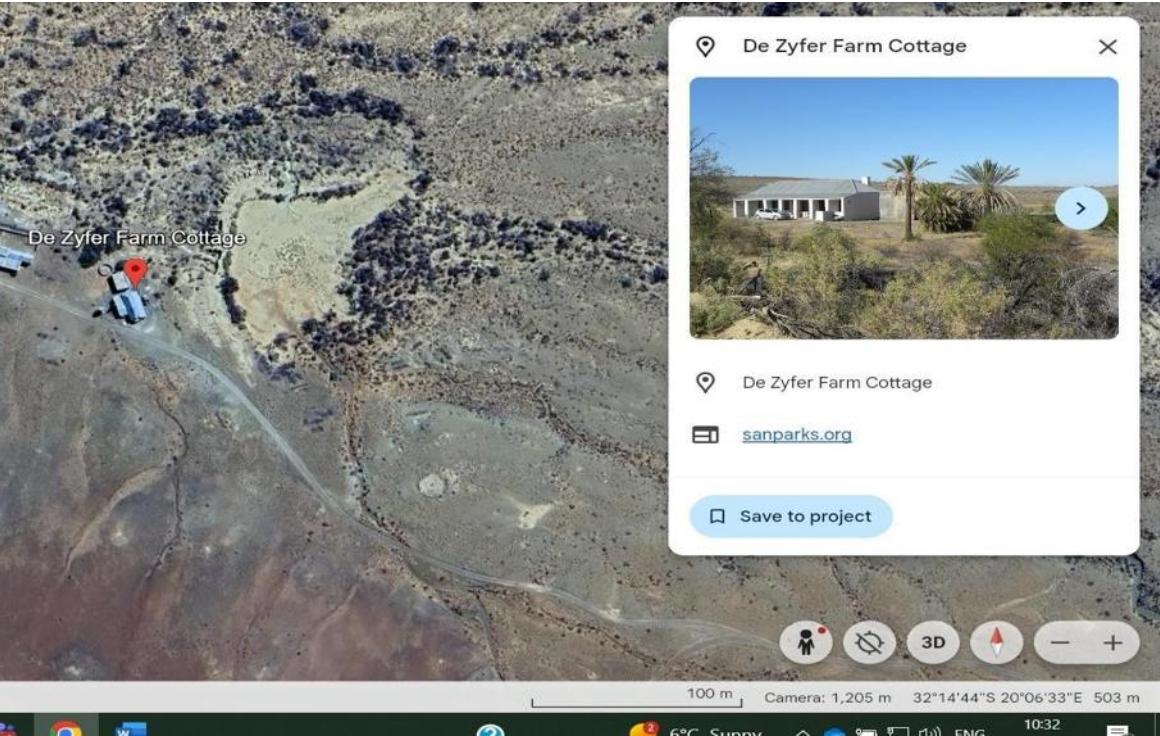
NOTE TO BIDDERS:

- Tankwa Karoo National Park does not have LTE or cellular network coverage. Therefore, bidders shall propose an alternative connectivity solution capable of providing reliable internet services. Acceptable technologies (e.g Satellite internet, licensed wireless solutions or any other suitable legally licensed technology.)
- Bidders are hereby informed that the service/delivery location is situated in a remote area.
- Bidders must take into account when preparing and submitting their bids, including pricing and logistics, travel, lead times and any associated costs.

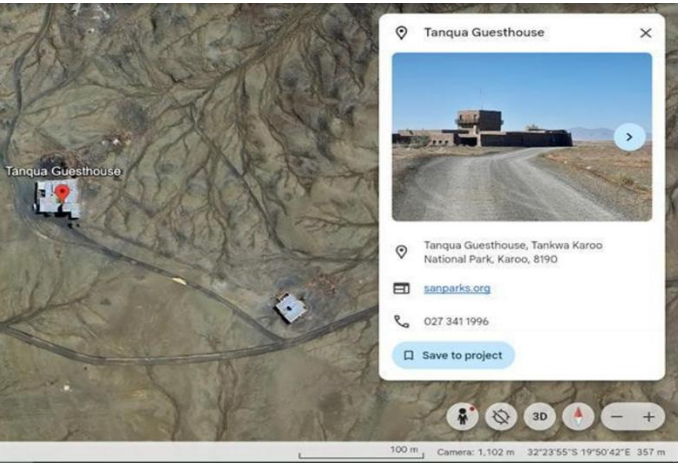
