1. PURPOSE

The purpose of this request is to appoint a service provider for the provision of plumbing services at the Wilderness section of the Garden Route National Park when the need arises for a period of three years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. TERMS OF REFERENCE

Services expected for this contract:

1. Annual service of water purification plants
2. Annual service of sewer plants
3. Service and repairs of submersible pumps
4. Plumbing installations including replacement/installation of electric water heaters(geysers) or related equipment e.g. Kitchen top or shower head water heaters.
5. Repairs of Bulk water reticulation systems and related equipment
6. Installation of pumps and related control equipment
7. Water proofing of reservoirs
8. Installation of solar water heating systems and related maintenance
9. Building of septic tanks, conservancy tanks, drains and reservoirs
10. Supply and installation of water tanks as and when required
11. Installation of new water supply lines or sewer pipelines
12. Maintenance of water pipelines which include cleaning, repairs and replacement of damaged piping and fittings.
13. Water/sewer line detection and mapping
14. Annual infrastructure inspection – detailed reports on preventative procedures to prolong life span of installed equipment and machinery

4. MANDATORY REQUIREMENTS

Bidders who fail to meet the mandatory requirements below will be disqualified and will not be evaluated further.

- Bidder must have an active CIDB grading of **1SO or higher or 1ME or higher or 1CE or higher**
- Bidder must **fully complete** the compulsory enterprise questionnaire at the end of this document
- Proof of valid Letter of Good Standing on Compensation for Occupational Injuries & Disease Act (**COIDA**) from Department of Labour or an institution accredited by Department of Labour.

5. REQUIREMENTS

- Bidders must provide the technician's valid plumbing trade certificate

6. SPECIAL CONDITIONS

Turn-around time for callouts must not exceed six (6) hours, therefore, bidders must be located within close proximity to Wilderness National Park in order to attend call outs within 6 hours as mentioned above.

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.
