1. PURPOSE

The purpose of these terms of reference (ToR) is to invite bidders to submit quotations for provision of catering for Kids in parks program for Camdeboo National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

KIDS IN PARKS PROGRAM MEALS PREPARATION

The Kids in Parks program will be held at Camdeboo National Park Environmental Education Centre, 13 km out of Graaff-Reinet on the road to Aberdeen. The program will host 2 groups per week consisting of 35 pax per day from 24 August to 15 October 2026 excluding weekends.

The services required are as follows:

- ✓ Preparation of breakfast (7H00), Lunch (13H00) and dinner (18H00) as well as snacks daily.
- ✓ All catering equipment, cutlery, crockery, braai facilities, firewood and gas will be provided by SANParks.
- ✓ The service provider shall supply buckets and jugs for mixed juice.
- ✓ Each group will be accommodated for a period of 2 nights and 3 days and is to be provided with a 4x snack, 2x lunch, 2x dinner, 2x breakfast. (See attached menu and school schedule).
- ✓ Day one of each group lunch and snack to be packed and served offsite. All other meals and snacks to be served at the EE center.
- ✓ Washing all pots, crockery and cutlery associated with meal provision.
- ✓ Always keep the kitchen and braai area clean and hygienic.

The quoted unit prices for meals must be fully inclusive of all labour, preparation, supervision, overheads, and associated costs. Transport costs must be quoted separately in the pricing schedule.

3.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

3.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
