1. PURPOSE

The purpose of these terms of reference (ToR) is to invite bidders to submit quotations for provision of transport for kids in parks program for Camdeboo National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

The Kids in Parks program will be held at Camdeboo National Park Environmental Education Centre, 13 km out of Graaff-Reinet on the road to Aberdeen. The program will host 2 groups per week consisting of 29 pax per day from 24 August to 15 September 2026 excluding weekends).

The services will be required for the following:

- ✓ The service provider shall provide 2 x 15-seaters with a valid PDP driver's license to transport learners from identified schools to the Valley of Desolation, Game Viewing Area then to Camdeboo EE Centre for 12 X Schools on the below schedule.
- ✓ The service provider shall transport learners and educators from the selected schools as indicated on the below schedule 08H00am on pick up day until 15H00pm on day 1.
- ✓ The service provider shall transport learners and educators at the Camdeboo EE Centre at 08H00pm for drop off at school on day 3.

The quotation should reflect the cost of transport per kilometer per Quantum for 18 days during which the services will be required. Log sheet to be provided as a supporting document.

- (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system, then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.
