1. PURPOSE

The purpose of this exercise is to appoint a service provider to design, build and undertake the post-event dismantling of high-quality exhibition stands and two activation zones for SANParks Vision 2040 Indaba to be held from 21–23 September 2026 taking place at Anew Resort in Mbombela, Mpumalanga. The appointed service provider will be required to conceptualise and deliver professional, innovative and functional exhibition and activation spaces that are aligned with the theme and objectives of the Vision 2040 Indaba, while complying with SANParks' corporate branding, sustainability and greening requirements. The exhibition stands and activation zones will comprise the following:

- Exhibition Stand 1 (Imvubu Hall): Design and construct exhibition stands within the Imvubu Hall, which measures approximately 22.3 m x 16.3 m, to accommodate 35 Micro, Small and Medium enterprises. The design should optimise the available space while ensuring that each exhibitor has an appropriate and functional exhibition area.
- Exhibition Stand 2: Design and construct an exhibition stand of approximately 108 m² to accommodate 10 exhibitors from various organisations, including suitable exhibition infrastructure, branding and supporting elements. **This will be an outdoor, as such a tent must be erected to accommodate the 10 organisations.**
- Activation Zone 1 (Youth voices): Design and create an interactive activation space of approximately 2.4 m x 3 m to facilitate youth engagement, dialogue, participation and interaction during the Indaba. This will be in a foyer outside the hall.
- Activation Zone 2 (African Traditional Practices): Design and create an activation space of approximately 3 m x 3 m to provide an immersive platform for showcasing African traditional practices, indigenous knowledge systems and cultural heritage. **This will be in a foyer outside the hall.**

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

Vision 2040 Indaba is being positioned as a premier leader in conservation dialogue beyond protected areas. It provides exhibitors with an opportunity to showcase biodiversity economy related products and services to a wider audience, while facilitating business linkages and market access opportunities.

For MSMEs, participation in the Indaba enables direct exposure to market and potential funders, networking with industry stakeholders, and opportunities for investment and contract acquisition. For SANParks, the platform is instrumental in advancing its enterprise and supplier development mandate, particularly in line with Vision 2040, which promotes an inclusive conservation economy that integrates communities adjacent to National Parks and those within Mega Living Landscapes.

3. SCOPE OF WORK

The SANParks Vision 2040 Indaba will be held under the theme **"A Century Forward: Building an Inclusive Conservation Legacy for 2040."** The theme marks the celebration of 100 years of Kruger National Park and reflects SANParks' deliberate shift from reflecting on the history of conservation towards actively shaping an inclusive and sustainable future for conservation in South Africa. Anchored in the legacy of Kruger National Park, the theme recognises the lessons and achievements of the past while positioning conservation as a shared national asset that should create meaningful social and economic value for all South Africans.

In line with the theme and objectives of the Indaba, the appointed service provider will be required to design, construct, install, brand and dismantle **two exhibition stands and two activation zones** that are innovative, professional, visually appealing, interactive and aligned

with the SANParks corporate identity and greening requirements. The design and branding of all exhibition stands and activation zones must create a cohesive visual identity throughout the venue and incorporate, where applicable: the SANParks corporate logo; the Vision 2040 logo; the Kruger National Park Centenary logo; logos and/or appropriate branding of participating MSMEs and organisations; high-quality images relevant to the participating exhibitors and the objectives of the Vision 2040 Indaba; and appropriate messaging and visual elements reflecting the theme.

The service provider will be expected to work closely with SANParks to ensure that all designs, branding, colours, imagery, materials and other visual elements comply with the approved SANParks corporate identity and event branding guidelines.

The detailed requirements for each exhibition stand and activation zone are outlined below:

3.1. **Exhibition Stand 1 (Imvubu Hall)**

Design and construct exhibition stands within the Imvubu Hall, which measures approximately 22.3 m x 16.3 m, to accommodate 35 Micro, Small and Medium enterprises. The design should optimise the available space while ensuring that each exhibitor has an appropriate and functional exhibition area. The exhibition stands should comprise of the following:

- Single tier – built on floor space Size: 22.3 m x 16.3 m
- 35 X Exhibition Desks/Table with each MSME branding
- Two chairs for company representative and 1 chair for a visitor should be made available at each stand
- Lighting and plug points
- Allowance for visitors' flow / movement space
- Exhibition / Visual display equipment panels/light boxes
- Brochure racks
- TV screen
- Functional areas:
 - Reception/customer service counter with lockable shelves
 - Beverage/ coffee station
 - A stage to host a business talk and investment pitch

3.2. **Exhibition Stand 2:**

Design and construct an exhibition stand of approximately 108 m² to accommodate 10 exhibitors from various organisations, including suitable exhibition infrastructure, branding and supporting elements. This will be an outdoor, as such a tent must be erected to accommodate the 10 organisations. The exhibition stands should comprise of the following:

- Single tier – built on floor space Size: 108 m²
- 10 X Exhibition Desks/Table with each organisation's branding
- Two chairs for officials from the organisation and 1 chair for a visitor should be made available at each stand
- Lighting and plug points
- Allowance for visitors' flow / movement space
- Exhibition / Visual display equipment panels/light boxes
- Brochure racks
- Functional areas:
 - Reception/customer service counter with lockable shelves
 - Beverage/ coffee station

3.3. **Activation Zone 1 (Youth voices)**

Design and create an interactive activation space of approximately 2.4 m x 3 m to facilitate youth engagement, dialogue, participation and interaction during the Indaba. This will be in a foyer outside the hall which is an open space. As such provisions should be made incase there is bad weather. The Activation zone should comprise of the following:

- 1 high table
- 4 high chairs
- Charging station with USB ports
- A backdrop with appropriate images aligned with the theme

3.4. **Activation Zone 2 (African Traditional Practices)**

Design and create an activation space of approximately 3 m x 3 m to provide an immersive platform for showcasing African traditional practices, indigenous knowledge systems and cultural heritage. This will be in a foyer outside the hall. The activation zone should comprise of the following:

- 1 table
- 2 chairs
- Charging station
- A backdrop with appropriate images aligned with the theme A high-quality branded backdrop incorporating imagery that reflects: Indigenous knowledge systems, African cultural heritage, traditional healing practices and storytelling traditions

4. **CONFIDENTIALITY**

The appointed service provider shall:

- Treat all SANParks information, documents, designs, artwork, data, and materials as confidential.
- Use such information solely for purposes of delivering services under this contract.
- Not disclose any SANParks information to third parties without prior written approval.
- Ensure that its employees, agents, and subcontractors comply with these confidentiality requirements.
- Return or destroy all confidential information upon request or upon termination of the contract.
- Maintain these confidentiality obligations for five (5) years after termination or expiry of the contract.
- Any breach of confidentiality may result in contract termination and legal action by SANParks.

5. **FUNCTIONALITY / TECHNICAL REQUIREMENTS**

- The purpose of this evaluation is to determine the bidder's professional competence, specialized experience in the design and building of exhibition stands and post-event dismantling, and the technical expertise of the proposed personnel.
- The minimum qualifying score for functionality is **75 points out of 100**. Only bidders who achieve this threshold or higher will be considered and proceed to the next stage of evaluation (Price and Specific Goals/Preference Points). Bidders who fail to meet the minimum threshold will be disqualified.

South African National Parks (SANParks) cannot amend the National Treasury's General Conditions of Contract (GCC). Where the supplies or services referred to in clauses 8.2 and 8.3 do not comply with the contract requirements, irrespective of whether such supplies or services are accepted or not, the supplier shall defray the cost in connection with these inspections, tests, or analyses. 8.6. Supplies and services referred to in clauses 8.2 and 8.3 and which do not comply with the contract requirements may be rejected. 8.7. Any contract supplies may on or after delivery be inspected, tested or analysed and may be rejected if found not to comply with the requirements of the contract. Such rejected supplies are held at the cost and risk of the supplier who shall, when called upon, remove them immediately at his own cost and forthwith substitute them with supplies, which do comply with the requirements of the contract. Failing such removal the rejected supplies shall be returned at the suppliers cost and risk. Should the supplier fail to provide the substitute supplies forthwith, the purchaser may, without giving the supplier further opportunity to substitute the rejected supplies, purchase such supplies as may be necessary at the expense of the supplier. 8.8. The provisions of clauses 8.4 to 8.7 shall not prejudice the right of the purchaser to cancel the contract because of a breach of the conditions thereof, or to act in terms of Clause 23 of GCC.
GCC9	9. Packing
	9.1. The supplier shall provide such packing of the goods as is required to prevent their damage or deterioration during transit to their final destination, as indicated in the contract. The packing shall be sufficient to withstand, without limitation, rough handling during transit and exposure to extreme temperatures, salt, and precipitation during transit, and open storage. GCC11	11. Insurance
	11.1. The goods supplied under the contract are fully insured in a freely convertible currency against loss or damage incidental to manufacture or acquisition, transportation, storage and delivery in the manner specified in the SCC.
GCC12	12. Transportation

	12.1. Should a price other than an all-inclusive delivered price be required, this shall be specified in the SCC.
GCC13	13. Incidental services
	13.1. The supplier may be required to provide any or all of the following services, including additional services, if any, specified in SCC: 13.1.1. Performance or supervision of on-site assembly and/or commissioning of the supplied goods; 13.1.2. Furnishing of tools required for assembly and/or maintenance of the supplied goods; 13.1.3. Furnishing of a detailed operations and maintenance manual for each appropriate unit of the supplied goods; 13.1.4. Performance or supervision or maintenance and/or repair of the supplied goods, for a period of time agreed by the parties, provided that this service shall not relieve the supplier of any warranty obligations under this contract; and 13.1.5. Training of the purchaser's personnel, at the supplier's plant and/or on-site, conducted in assembly, start-up, operation, maintenance, and/or repair of the supplied goods. 13.2. Prices charged by the supplier for incidental services, if not included in the contract price for the goods, shall be agreed upon in advance by the parties and shall not exceed the prevailing rates charged to other parties by the supplier for similar services.
GCC14	14. Spare parts
	14.1. As specified in SCC, the supplier may be required to provide any or all of the following materials, notifications, and information pertaining to spare parts manufactured or distributed by the supplier: 14.1.1. This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise in SCC. 15.3. The purchaser shall promptly notify the supplier in writing of any claims arising under this warranty.

	15.4. Upon receipt of such notice, the supplier shall, within the period specified in SCC and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser. 15.5. If the supplier, having been notified, fails to remedy the defect(s) within the period specified in SCC, the purchaser may proceed to take such remedial action as may be necessary, at the supplier's risk and expense and without prejudice to any other rights, which the purchaser may have against the supplier under the contract.
GCC16	16. Payment
	16.1. The method and conditions of payment to be made to the supplier under this contract shall be specified in SCC. 16.2. The supplier shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract. 16.3. Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the supplier. 16.4. Payment will be made in Rand unless otherwise stipulated in SCC
GCC17	17. Prices
	17.1. Prices charged by the supplier for goods delivered and services performed under the contract shall not vary from the prices quoted by the supplier in his bid, with the exception of any price adjustments authorized in SCC or in the purchaser's request for bid validity extension, as the case may be.
GCC18	18. Contract amendment
	18.1. No variation in or modification of the terms of the contract shall be made except by written amendment signed by the parties concerned.
GCC19	19. Assignment
	19.1. The supplier shall not assign, in whole or in part, its obligations to perform under the contract, except with the purchaser's prior written consent.
GCC20	20. Subcontract
	20.1. The supplier shall notify the purchaser in writing of all subcontracts awarded under this contract if not already specified in the bid. Such notification, in the original bid or later, shall not relieve the supplier from any liability or obligation under the contract
GCC21	21. Delays in supplier's performance
	21.1. Delivery of the goods and performance of services shall be made by the supplier in accordance with the time schedule prescribed by the purchaser in the contract. 21.2. If at any time during performance of the contract, the supplier or its subcontractor(s) should encounter conditions impeding timely delivery of the goods and performance of services, the supplier shall promptly notify the purchaser in writing of the fact of the delay, its likely duration, and its cause(s). As soon as practicable after receipt of the supplier's notice, the purchaser shall evaluate the situation and may at his discretion extend the supplier's time for performance, with or without the imposition of penalties, in which case the extension shall be ratified by the parties by amendment of contract. 21.3. No provision in a contract shall be deemed to prohibit the obtaining of supplies or services from a national department, provincial department, or a local authority.

	21.4. The right is reserved to procure outside of the contract small quantities or to have minor essential services executed if an emergency arises, the supplier's point of supply is not situated at or near the place where the supplies are required, or the supplier's services are not readily available. 21.5. If the Supplier fails to perform any other obligation(s) under the contract; or 23.1.3. If the supplier, in the judgment of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 23.2. In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the supplier shall be liable to the purchaser for any excess costs for such similar goods, works or services. However, the supplier shall continue performance of the contract to the extent not terminated. 23.3. Where the purchaser terminates the contract in whole or in part, the purchaser may decide to impose a restriction penalty on the supplier by prohibiting such supplier from doing business with the public sector for a period not exceeding 10 years. 23.4. If a purchaser intends imposing a restriction on a supplier or any person associated with the supplier, the supplier will be allowed a period of not more than fourteen (14) days to provide reasons why the envisaged restriction should not be imposed.
