## INTRODUCTION TO SANPARKS

SANParks was initially established in terms of the now repealed National Parks Act, 57 of 1976 and continue to exist in terms of the National Environmental Management: Protected Areas Act, 57 of 2003; with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: 25 public entity.

Our **vision** is a future where people and nature thrive together in sustainable mega living landscapes.

Our **mission** is to conserve, expand and sustainably manage South Africa's natural and cultural assets, for the wellbeing of present and future generations, through innovation and inclusive partnerships with communities.

## BUSINESS UNIT RESPONSIBLE FOR THE BID

Enterprise Risk Management (ERM) Department reports to the Head of Governance, Risk and Compliance. The ERM Department is responsible for assisting the organisation to embed risk management and leverage its benefits to enhance performance, through the development and maintenance of an efficient, effective and transparent risk management system as per the requirements of the Public Finance Management Act, 1999, the Treasury Regulations, 2005 and Public Sector Risk Management Framework, 2010.

## CONTEXT OF THIS PROCUREMENT

SANParks Vision 2040 represents a strategic shift from a traditional protected area model towards Mega Living Landscapes that integrate biodiversity conservation, socioeconomic development, stakeholder participation, climate resilience and regenerative tourism. Vision 2040 seeks to promote ecological sustainability and social inclusion through partnerships across landscapes involving government, communities, traditional authorities, civil society, landowners and the private sector.

As part of its Vision 2040 Risk Management Framework, SANParks intends conducting a Risk Perception Survey (RPS) to identify, validate, prioritise and analyse risks that may affect implementation of Vision 2040 and achievement of its strategic objectives. The survey must provide insights into current and future risk concerns, stakeholder perspectives and emerging risk hotspots.

The purpose of the assignment is to appoint a suitably qualified service provider to:

- Design and administer a comprehensive Risk Perception Survey.
- Obtain risk perceptions from internal and external stakeholders.
- Analyse current and emerging risks affecting Vision 2040 implementation.
- Determine stakeholder views regarding risk severity, likelihood and impact.
- Assess changes in risk significance over short, medium and long-term horizons.
- Identify risk interdependencies and compounding risks.
- Inform the development and refinement of the Vision 2040 Risk Register and Risk Management Plan.
- Provide evidence-based recommendations for risk treatment, mitigation and monitoring.

The specific objectives are to:

Validate and refine the preliminary Vision 2040 risks already identified by SANParks, including risks associated with:

- Conservation area management
- Inclusive economic growth
- Regenerative tourism

## **B. Identify Emerging Risks**

## **C. Determine Risk Perception**

Measure stakeholders' perceptions regarding:

- Likelihood of occurrence.
- Potential impact.
- Velocity/speed of onset.
- Duration of impact.
- Ability of SANParks and partners to manage the risk.
- Confidence in current controls and governance arrangements.

## **D. Time Horizon Analysis**

Assess risk significance over:

- 1-year horizon
- 2-year horizon
- 10-year horizon

## **CONTRACT PERIOD**

The contract duration is twelve (12) months
