1. PURPOSE

South African National Park seeks to appoint a service provider for the maintenance of all water pumps, boreholes, and pool pumps at AENP for a period of two (2) years.

BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

2. SCOPE OF WORK

Addo Elephant National Park intends to appoint a service provider for the maintenance of water pumps, pool pumps and diesel engines Addo Elephant National Park for a period of six months.

The scope of work entails the repair of a variety of pumps utilized by the Addo Elephant National Park. Repairs and maintenance work on existing and any other pumps that Addo Elephant National Park may purchase during the contract period. Repair and maintenance services will be required when the need arises.

The contractor is responsible to determine the cause of fault based on the symptom, and to effect necessary pump repairs to maintain the original efficiency to acceptable standards. This may include complete overhaul and assembly. For every pump that has been repaired a detailed test report, certificate and pump performance curve shall be submitted to the client.

The service provider will be required to maintain and keep proper record of pumps serviced, repaired or maintained.

RESPONSIBILITIES OF THE BIDDER

1. Extract pump below natural ground level and clean pumps
2. Replace all filters (e.g. oil filters, air filters etc.)
3. Check and replace oil and greasing movable parts
4. Replacement parts
5. Consumables
6. Checking pumps electrical control systems including solar
7. Checking mechanical seals

8. Checking condition of bearings
9. Check leakages on engine and pump
10. Check and repair engine frame and mounting
11. Service provider must have a local office/workshop within 150km from the AENP.
12. Compile and submit all technical information on a specific borehole (depth, pump details, yield of borehole)
