## **1. PURPOSE**

The purpose of this RFQ is for Provision of professional services for the development, maintenance and support of the Microsoft Dynamics GP (Great Plains) environment for a period of six (6) months.

## **2. BACKGROUND**

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

## **3. SCOPE OF WORK**

The successful service provider shall be responsible for the development, maintenance and support of the Microsoft Dynamics GP environment.

The scope shall include:

1. Provide second-line and technical support for the Microsoft Dynamics GP environment.
2. Receive, investigate, diagnose and resolve incidents and service requests escalated by SANParks.
3. Troubleshoot Microsoft Dynamics GP application, database, reporting and integration-related issues.
4. Provide corrective and preventive maintenance of the existing Dynamics GP environment.

5. Develop, configure, test and implement approved enhancements and change requests.
6. Maintain and optimise existing Dynamics GP business processes and functionality.
7. Provide business analysis and technical analysis where required for approved changes and enhancements.
8. Support existing interfaces and integrations between Dynamics GP and other SANParks internal and external systems.
9. Provide Microsoft SQL Server technical support relating to the Dynamics GP environment, including troubleshooting and performance optimisation.
10. Maintain and support existing reports and develop additional reports where required.
11. Review and improve existing source code and technical documentation and reduce hard-coded functionality where reasonably possible.
12. Provide technical guidance and recommendations regarding the stability, performance and continued operation of the Dynamics GP environment.
13. Support application security, user access, roles and permissions where required.
14. Support approved application patches, fixes and configuration changes. Plan, assess, test and implement approved Microsoft Dynamics GP version upgrades, including the required upgrade path from the current Dynamics GP 18.00 environment to Dynamics GP 18.3 and subsequently Dynamics GP 18.5, or a later SANParks-approved supported version. This shall include prerequisite assessments, compatibility verification, testing, deployment planning, rollback planning and post-upgrade validation.
15. Provide end-user and technical support to the SANParks internal Finance and ICT support teams. Assess, remediate, upgrade, configure and test existing third-party add-ons, customisations, integrations, Web Services and related components to ensure compatibility with the target Dynamics GP version.
16. Provide knowledge transfer to designated SANParks resources throughout the contract period.

17. Maintain appropriate technical, configuration and support documentation for work performed.

18. Participate in technical and service review meetings when required by SANParks.

## **SERVICE DELIVERY REQUIREMENTS**

- The service provider shall provide services remotely and on-site where required by SANParks.
- All incidents and service requests shall be managed through the SANParks-approved service management process.
- The service provider shall provide suitably qualified resources for the duration of the contract and ensure continuity of service where an assigned resource becomes unavailable.
- Critical incidents affecting the availability of the Dynamics GP environment or critical financial operations shall receive priority attention.
- All production changes shall be implemented in accordance with SANParks change management and approval processes.

## **DELIVERABLES**

The service provider shall provide, as applicable:

- Resolution of logged incidents and service requests.
- Completed and tested approved enhancements.
- Technical and functional documentation.
- Updated source code and configuration documentation.
- Integration support and fixes.
- Monthly service and performance reports.
- Monthly resource utilisation report.
- Knowledge transfer to SANParks resources.
- Updated incident, problem and change registers.
- Recommendations relating to system performance, stability and risks.

- Contract closure and handover report at the end of the six-month period.

## **MONTHLY REPORTING**

The service provider shall submit a monthly report detailing:

- Incidents received, resolved and outstanding.
- Service requests received and completed.
- Development and enhancement activities.
- Changes implemented.
- Resource utilisation and hours consumed.
- System risks and issues.
- Outstanding activities.
- Recommendations.
- Planned activities for the following month.

The monthly report and supporting evidence shall accompany the applicable invoice.

## **4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)**

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with requirements as stipulated below:

- Submission of fully completed SBD1 (Invitation to Bid),
- Submission of a quotation on the company letterhead,
- Submission of fully completed SBD 4 (Bidder's disclosure),
- Submission of fully completed SBD 6.1 (accompanied by the original or certified B-BBEE Status Level Verification Certificate or B-BBEE Sworn Affidavit). (DTIC/CIPC)
- Submission of fully completed SBD 7.2 Contract Form
- Submission of General Conditions of a Contract



## 5. MANDATORY REQUIRMENTS

Bidders will be disqualified if they do not fully comply with all mandatory requirements. No “unanswered” questions will be allowed. If a response to a question has been indicated as comply but not elaborated upon or substantiated it shall be regarded as mandatory non-compliance, and the bidder shall be disqualified.
