1. PURPOSE

The purpose of the exercise is to appoint a reputable contractor for maintenance work at the regional office of the Garden Route National Park as per scope below

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. MANDATORY REQUIREMENTS

Bidders who fail to meet the mandatory requirements below will be disqualified and will not be evaluated further.

- Bidder must have an active CIDB grading of **1GB or higher**
- Bidder must **fully complete** the compulsory enterprise questionnaire at the end of this document
- Proof of valid Letter of Good Standing on Compensation for Occupational Injuries & Disease Act (**COIDA**) from Department of Labour or an institution accredited by Department of Labour.
- Attendance at the compulsory site briefing

4. SPECIAL CONDITIONS

The Office building consists of a ground floor and a top floor.

- Contractor must be registered with CIDB grading of 1 GB or higher
- The site meeting is compulsory
- All quantities must be confirmed by contractor on site as SANParks will not take any responsibility for incorrect measurements
- Contractor to supply all materials and tools required for the work. This includes scaffolding and ladders where needed.
- All paint purchased must be approved by the Technical Manager before painting starts
- All work including preparation must be inspected. Painting may not be started if preparation work was not approved by technical manager
- **Contractor to ask for inspections prior to painting any surface**
- Please note that record must be kept at the time and date of inspections and date of application of paint coats
- Technical Manager must inspect between coats; no paint work may proceed without inspections. All inspection sheets must be signed
- Maintenance work to buildings must be done according to specifications and manufacturer instructions
- The successful bidder will be required to provide a schedule/timeline for the days of completion of the work.
- The work is in close proximity of the Knysna Lake Area, and all environmental precautions must be taken.
- A certified plumber to do repairs in bathrooms (**Proof of certification must be provided before plumbing work is done**)
- All workers must always wear PPE. Failure will lead to contract cancellation
- Safety files must be available before the work starts. A safety representative must always be on site.
- Ensure that all safety measures required are implemented such as working on heights, working with paint, etc.
- Ensure that decking and paving areas are covered with spill sheets

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
