1. PURPOSE

The purpose of this request is to appoint a service provider for the service and maintenance of 200kva standby generator at the Ebb & Flow Rest Camp, Wilderness section of the Garden Route National Park for a period of three years.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. TERMS OF REFERENCE

1. Scope of Work (Maintenance)

- Preventative Maintenance Visits: Usually split into minor (bi-annually) and major (annually) services.
- Lubrication System: Drain engine oil, replace filters, and dispose of used oil in a regulatory-compliant manner.
- Fuel System: Replace fuel filters (primary/secondary), inspect fuel lines, check for leaks, and drain water from the filter bowl.
- Cooling System: Inspect hoses/belts, check coolant levels, test coolant concentration, and replace coolant and jackets water heater annually.
- Air System: Replace air filters and clean the breather.
- Starting System: Test battery electrolyte level, clean connections, apply corrosion inhibitor, and load test the battery.
- Electrical System: Inspect generator set, ATS (Automatic Transfer Switch) for loose wiring, and test safety shutdowns.

2. Testing and Performance

- Load Bank Testing: Conduct annual or quarterly full-load bank testing to ensure the generator handles the load without overheating.
- Simulated Power Failure: Simulate a mains failure to confirm the ATS triggers, the engine starts within 10–15 seconds, and it transfers the load correctly.
- System Operation: Run the set on load for 30–60 minutes to monitor output voltage, frequency, and stability.

3. Requirements for Service Providers

- Regulatory Compliance: Work must adhere to local Electrical Installation regulations (e.g., SANS 10142-1) and OH&S Act standards.
- Emergency Response: Provide 24/7 technical support with defined on-site response times (e.g., 2–4 hours).

4. Reporting and Documentation

- Logbook Maintenance: Enter date of visit, tests carried out, and adjustments made in a logbook kept on-site.
- Service Report: Provide a detailed written report advising of any further work or parts required.
- Inventory: Maintain an up-to-date inventory of the generator components.

5. Contractual Terms

- Parts and Consumables: Clearly define if consumables (oil, filters) are included in the price or charged separately.
- Repair Approval: Requirement for the provider to submit a quotation for repairs beyond routine maintenance and obtain approval before starting work.
- Spare Parts Stock: Preference for contractors who hold common parts (filters, belts, sensors) to ensure prompt repairs.

Typical Maintenance Schedule

Monthly Visual inspection, run for 15 mins (no load), check oil/coolant levels.

Quarterly Inspect fuel/water separator, test Battery.

Annually Replace oil, filters, coolant; Load test; Clean generator/room.

4. MANDATORY REQUIREMENTS

Bidders who fail to meet the mandatory requirements below will be disqualified and will not be evaluated further.

- Bidder must have an active CIDB grading of **1EB or higher**
- Bidder must **fully complete** the compulsory enterprise questionnaire at the end of this document
- Proof of valid Letter of Good Standing on Compensation for Occupational Injuries & Disease Act (**COIDA**) from Department of Labour or an institution accredited by Department of Labour.

5. FUNCTIONALITY REQUIREMENTS

Bidders who fail to meet the minimum qualifying score **80%** will not be evaluated further for Price and specific goals. Points will be allocated as follows:

3 POINTS AWARDED FOR SPECIFIC GOALS

3.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

3.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
