1. PURPOSE

The purpose of this request is to appoint a reputable training service provider to provide training for Reg 21/79 Provision of Firearm training for a Total of 50 Delegates.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

The South African National Parks (SANParks) seeks to find a Sector Education and Training Authority Accredited Skills Development Provider (SDP) who will capacitate employees on Reg 21/79 Firearm Training in the unit standards listed below.

3.1 LOCATION OF THE TRAINING

The Skills Development Provider (SDP) must provide the training **venue** and **shooting range**.
Preferably in Thabazimbi.

3.2 RESPONSILITIES OF THE SDP

The Training Provider will undertake the following:

- Hold Scoping meeting/s with SANParks
- Deliver against a signed contract/Purchase Order
- Must keep the following registers:
 - Attendance Register;
 - Shooting Range Register;
 - A register wherein the following particulars must be recorded in respect of every person successfully trained by such accredited person-
 - ID No and full names of the person trained;
 - Date and place of the training;
 - Type of prescribed training;
 - in respect of practical training and testing, the type of firearm namely a handgun, rifle or shotgun including the action of the firearm for which training and testing was provided and the test results;
 - Feedback on the outcome of firearm training per person;
- Certificate undersigned by both the instructor and the person concerned confirming the particulars (No certificates issued to persons must have an expiry date);
- The registers must be available at the place of business of the Service provider and must be retained for a period of six years.
- Learner guidance and support is provided.
- Submission of Learner Evaluation Report, Training Close out report

3.3 MANDATORY REQUIREMENTS

The SDP must meet the following requirements and submit document proof:

a) PFTC

b) SAPS

Documentary proof that the Service Provider is registered with SAQAA, 1995 (Act No. 58 of 1995) as per the Skills Development Act, 1998 (Act No. 97 of 1998) with PFTC and SAPS as a service provider to provide the training contemplated in Legislation.

PFTC.

- Accreditation qualifications;
- Accreditation gradings;
- Verification report by PFTC;
- The Certificates must indicate the required Legal Unit standards for firearm training as mentioned under the terms of reference.

SAPS –

- Accreditation Certificate;
- SAPS Annual report regarding all persons trained;
- Experience -
 - Not less than 5 years' experience as a Service Provider;
 - Quantity of persons trained annually will be highly considered.

A written undertaking

A written undertaking that any practical training or testing which will involve the actual firing of a firearm will only be conducted at an accredited shooting range. All shooting ranges of the Service Provider must be accredited with NRCS and SAPS.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner

required by the organ of state.

2 DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

3.1 In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

3.2 In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
